

TERMS AND CONDITIONS

These terms and conditions (the "Terms and Conditions") govern the use of **www.orchardhousecafe.co.nz** (the "Site"). This Site is owned and operated by MOST4U LIMITED. This Site is an ecommerce website.

By using this Site, you indicate that you have read and understand these Terms and Conditions and agree to abide by them at all times.

Intellectual Property

All content published and made available on our Site is the property of MOST4U LIMITED and the Site's creators. This includes, but is not limited to images, text, logos, documents, downloadable files and anything that contributes to the composition of our Site.

Acceptable Use

As a user of our Site, you agree to use our Site legally, not to use our Site for illegal purposes, and not to:

- Harass or mistreat other users of our Site;
- Violate the rights of other users of our Site;
- Violate the intellectual property rights of the Site owners or any third party to the Site;
- Hack into the account of another user of the Site;
- Act in any way that could be considered fraudulent; or

Accounts

When you create an account on our Site, you agree to the following:

1. You are solely responsible for your account and the security and privacy of your account, including passwords or sensitive information attached to that account; and

2. All personal information you provide to us through your account is up to date, accurate, and truthful and that you will update your personal information if it changes.

We reserve the right to suspend or terminate your account if you are using our Site illegally or if you violate these Terms and Conditions.

Sale of Goods And Services

These Terms and Conditions govern the sale of goods and services available on our Site.

The following goods are available on our Site:

- Food & Beverage;
- Merchandise; and
- Arts/Crafts/Gifts.

The following services are available on our Site:

- Catering; and
- Business Space.

The services will be paid for in full upon the completion of the service.

These Terms and Conditions apply to all the goods and services that are displayed on our Site at the time you access it. This includes all products listed as being out of stock. All information, descriptions, or images that we provide about our goods and services are as accurate as possible. However, we are not legally bound by such information, descriptions, or images as we cannot guarantee the accuracy of all goods and services we provide. You agree to purchase goods and services from our Site at your own risk.

We reserve the right to modify, reject or cancel your order whenever it becomes necessary. If we cancel your order and have already processed your payment, we will give you a refund equal to the amount you paid. You agree that it is your responsibility to monitor your payment instrument to verify receipt of any refund.

Third Party Goods and Services

Our Site may offer goods and services from third parties. We cannot guarantee the quality or accuracy of goods and services made available by third parties on our Site.

Payments

We accept the following payment methods on our Site:

- Credit Card;
- PayPal;
- Debit; and
- Direct Debit.

When you provide us with your payment information, you authorise our use of and access to the payment instrument you have chosen to use. By providing us with your payment information, you authorise us to charge the amount due to this payment instrument.

If we believe your payment has violated any law or these Terms and Conditions, we reserve the right to cancel or reverse your transaction.

Shipping and Delivery

When you purchase goods from our Site, the goods will be delivered through one of the following methods:

- Nationwide 1-3 Days.

Delivery will take place as soon as reasonably possible, depending on the delivery method selected. Delivery times may vary due to unforeseen circumstances. Please note that delivery times do not include weekends and statutory holidays.

You will be required to pay delivery charges in addition to the price for the goods you purchase.

You are required to provide us with a complete and accurate delivery address, including the name of the recipient. We are not liable for the delivery of your goods to the wrong address or wrong person as a result of you providing us with inaccurate or incomplete information.

Refunds

Refunds for Goods

Refund requests must be made within 14 days after receipt of your goods.

We accept refund requests for goods sold on our Site for any of the following reasons:

- Good is broken;
- Good does not match description; or
- Good is the wrong size.

Refunds do not apply to the following goods:

- Clearance Items; and
- Other items expressed as non-returnable due to labelled defects.

Refunds for Services

We provide refunds for services sold on our Site as follows:

- Functions & Group Bookings 12 pax or larger:
If our services are cancelled at least 48 hours prior to the event then there will be no charge and any deposits paid will be returned.
If our services are cancelled within 48 hours prior to commencing, then we will collect or charge either the deposit paid or 10% of the quoted total.
For bookings with less than 12 pax, cancellations can be made up to an hour prior with no charge. For cancellations within the hour, or for no-shows, the users account/s will be flagged for any further bookings made.

Returns

Returns can be made in person at the following location(s): In store or by return mail.

Returns can be made by mail. To return a good by mail, follow the following procedure:

Call or email us to request a return label. Please pack your goods carefully and attach the return label on the top side of the package.

Failure to package the goods correctly (as per NZ Post guidelines) may result in the return being voided should it go missing or be damaged in transit. Please note that if this occurs we reserve the right to cancel any refunds, due to incorrect or insufficient packing.

Consumer Protection Law

Where the *Consumer Guarantees Act 1993*, the *Contract and Commercial Law Act 2017*, or any other consumer protection legislation in your jurisdiction applies and cannot be excluded, these Terms and Conditions will not limit your legal rights and remedies under that legislation. These Terms and Conditions will be read subject to the mandatory provisions of that legislation. If there is a conflict between these Terms and Conditions and that legislation, the mandatory provisions of the legislation will apply.

Links to Other Websites

Our Site contains links to third party websites or services that we do not own or control. We are not responsible for the content, policies, or practices of any third party website or service linked to on our Site. It is your responsibility to read the terms and conditions and privacy policies of these third party websites before using these sites.

Limitation of Liability

Indemnity
